**Waiver of Liability, Assumption of Risk, and Indemnity of Agreement**

**Waiver:** In return for being permitted to participate in the following activity or program ("The Activity"), including any associated use of the premises, facilities, staff, equipment, transportation, and services of the University, I, for myself, heirs, personal representatives, and assigns, **do hereby release, waive, discharge, and promise not to sue Splash at UCLA** and its agents, from liability **from any and all claims, including the negligence of Splash at UCLA** and its agents, resulting in personal injury (including death), accidents or illnesses, and property loss, in connection with my participation (including transportation, if applicable) in the Activity.

**Indemnification and Hold Harmless:** I also agree to indemnify and hold **Splash at UCLA, HARMLESS** from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in The Activity and to reimburse them for any expenses incurred.

**Severability:** The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad an inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
